2. Review/approve minutes of February 11, 2019.

The committee reviewed the minutes and any posted comments. Karen Cote (KC) moved to approve the minutes as entered and Katie Greenman (KG) seconded. The minutes were unanimously approved.

3. Chair Report

Dexter Johnson (DJ) reviewed with the committee a recent email contact from Jake Maier about his meeting with the Orland Selectboard about Tree City USA and applying for grants. DJ thinks this work on Tree City USA would be applicable to the Comprehensive Plan Goals and Objectives section.

Alvion Kimball (AK) also has approached DJ about putting something into the Goals and Objectives section of the Comprehensive Plan on the beautification of the waterfront park on Narramissic Drive.

4. Old Business

Review of Public Services and Facilities continued.

The committee reviewed changes Bart McGraw (BM) had made to Education tables V.1, V.2, and V.3. The table changes/updates were approved and with the updates to table V.2 on Projected Enrollment trends the committee felt there was no need to also create a chart to represent this data. BM will complete his updates and delete redundant tables.

Part (9) Fire Protection comments were reviewed and resolved for Part A on staffing, Part B on facilities, and Part C on vehicles and equipment.

Part (13) Healthcare Facilities and Social Services, a comment regarding the name changes with local hospitals to include Northern Light Healthcare was resolved.

Part (14) Table V.7 Orland Town Officials and Employees, updates to the table were reviewed and accepted.

Part (16) Naramissic River Dam comments were resolved.

The Public Services and Facilities chapter date was changed to 2-25-2019.

5. New Business

Review of Recreation Draft Chapter.

Part A Public Recreational Facilities and Overview was reviewed and comments resolved. The existence of an Orland Recreational Committee was noted and a change of the Bucksport Rec. Department to the Bucksport YMCA (run by the Downeast Family YMCA in Ellsworth) as recreational program provider. The formatting at the start of the chapter was changed to include a list notation of A. B. C, as only C is noted in the chapter.

Part B Activities comments were reviewed and comments resolved. In V1.5 Current and Future Adequacy John Bradford (JB) suggested a rewrite of the opening paragraph and moving the last sentence of the paragraph to the Goals and Objectives for Recreation.

The Recreation chapter review was completed, the date changed to 2-25-2019, and it was moved into the final chapters folder.
