

# PARKING AND TRAFFIC ORDINANCE

## TOWN OF ORLAND, MAINE

**TITLE:** This Parking Ordinance shall be known and may be cited as the “Parking and Traffic ordinance of the Town of Orland, Maine”.

**ENACTING CLAUSE:** Be it enacted by the Board of Selectmen in accordance with Title 30-A M.R.S.A. Section 3009, the following ordinance regulating the operation of vehicles within the Town of Orland, Maine.

### **SECTION 1: Purpose**

The purpose of this ordinance is to insure the public safety, to facilitate snow removal and sanding, fire suppression, and to relieve traffic hazards and congestion through the regulation of on-street parking and vehicular traffic flow in the Town of Orland, Maine.

### **SECTION 2: Prohibited Parking Areas**

No person shall park, stand, or leave a motor vehicle in the following specified areas:

- A. On all streets, roads, and public ways from November 1<sup>st</sup> to April 1<sup>st</sup>, from 1am to 6am, or during snow weather emergencies;
- B. On both sides of the station entrance, between pole NET 8/8 and pole NET 6/06;
- C. Across the street from the entrance of the Town Office and Orland Consolidated School between pole CMP 3/17 and pole NET 260/5.

### **SECTION 3: Enforcement**

The Maine State Police, Hancock County Sheriff Department, and empowered Town of Orland Constables are directed to enforce the provisions of this Ordinance and to issue tickets to violators thereof.

### **SECTION 4: Penalties**

- A. Whoever violates or fails to comply with the provisions of Section 2 of this ordinance may waive all court action by the payment of a waiver fee of \$10.00 at the Orland Town Office prior to the expiration of the 30 day period following the issuance of the parking ticket;
- B. Violators or those who fail to comply with Section 2 of this ordinance, may have the motor vehicle towed at the owners expense;
- C. A summons may be issued to the District court, Ellsworth, Maine for any violation of this ordinance in the 30 day period following the issuance of a parking ticket. The violator shall be subject to a fine of not less that \$25.00

and not more than \$100.00, to be recovered to the use of the Town of Orland;

- D. All monies collected by this ordinance shall be turned over to the Town Treasurer for the use of the Town.

**SEVERABILITY CLAUSE:** If any section, subsection, sentence or part of this ordinance is for any reason held to be invalid or unconstitutional, such decisions shall not affect the validity of the remaining portions of this ordinance.

**EFFECTIVE DATE:** This ordinance shall become effective as of the date it is duly enacted by the Town of Orland and signed by the Board of Selectmen.
